The undersigned BIDDER proposes and agrees, if this Bid is accepted, to enter into an agreement with OWNER in the form included in the Contract Documents to perform and furnish all Work as specified or indicated in the Contract Documents for the Bid Price and within the Bid Times indicated in this Bid and in accordance with the other terms and conditions of the Contract Documents.
2. BIDDER accepts all of the terms and conditions of the Advertisement or Invitation to Bid and Instructions to Bidders, including without limitation those dealing with the disposition of Bid security. This Bid will remain subject to acceptance for ninety days after the day of Bid opening. BIDDER will sign and deliver the required number of counterparts of the Agreement with the Bonds and other documents required by the Bidding Requirements within fifteen days after the date of OWNER's Notice of Award.
3. In submitting this Bid, BIDDER represents, as more fully set forth in the Agreement, that:

BIDDER has carefully studied all reports of explorations and tests of subsurface conditions at or contiguous to the site and all drawings of physical conditions in or relating to existing surface or subsurface structures at or contiguous to the site (except Underground Facilities) which have been identified in the Supplementary Conditions as provided in paragraph 4.02 of the General Conditions. BIDDER accepts the determination set forth in paragraph SC-4.2 of the Supplementary Conditions of the extent of the "technical data" contained in such reports and drawings upon which BIDDER is entitled to rely as provided in paragraph 4.02 of the General Conditions. BIDDER acknowledges that such reports and drawings are not Contract Documents and may not be complete for BIDDER's purposes. BIDDER acknowledges that OWNER and ENGINEER do not assume responsibility for the accuracy or completeness of information and data shown or indicated in the Bidding Documents with respect to Underground Facilities at or contiguous to the site. BIDDER has obtained and carefully studied (or assumes responsibility for having done so) all such additional or supplementary examinations, investigations, explorations, tests, studies and data concerning conditions (surface, subsurface and Underground Facilities) at or contiguous to the site or otherwise which may affect cost progress, performance or furnishing of the Work or which relate to any aspect of the means, methods, techniques, sequences and procedures of construction to be employed by BIDDER and safety precautions and programs incident thereto. BIDDER does not consider that any additional examinations, investigations, explorations, tests, studies or data are necessary for the determination of this Bid for performance and furnishing of the Work in accordance with the times, price and other terms and conditions of the Contract Documents.

- e. BIDDER is aware of the general nature of Work to be performed by Owner and others at the site that relates to Work for which this Bid is submitted as indicated in the Contract Documents.
  - f. BIDDER has correlated the information known to BIDDER, information and observations obtained from visits to the site, reports and drawings identified in the Contract Documents and all additional examinations, investigations, explorations, tests, studies and data with the Contract Documents.
  - g. BIDDER has given ENGINEER written notice of all conflicts, errors, ambiguities or discrepancies that BIDDER has discovered in the Contract Documents and the written resolution thereof by ENGINEER is acceptable to BIDDER, and the Contract Documents are generally sufficient to indicate and convey understanding of all terms and conditions for performing and furnishing the Work for which this Bid is submitted.
  - h. This Bid is genuine and not made in the interest of or on behalf of any undisclosed person, firm or corporation and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation; BIDDER has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid; BIDDER has not solicited or induced any person, firm or corporation to refrain from bidding; and BIDDER has not sought by collusion to obtain for itself any advantage over any other Bidder or over OWNER.

\*\*Water Treatment Equipment Bid shall include all water treatment equipment, piping, pumps, etc. shown on drawings P1.1, P2.1, P2.2, P2.3, P2.4, P2.5, P3.1, P3.2, P3.4, P3.5 and related specifications. The base bid will be for equipment furnished by Artesian of Pioneer, Inc., 50 Industrial Ave., Pioneer, OH 43554.

\*\*\*Electrical Bid shall include all Electrical and Lighting work shown on drawing E1.1. and E3.1 and related specifications.

\*\*\*\*Mechanical Bid shall include all HVAC and Plumbing work shown on drawing M1.1 and M2.1 and related specifications.

The bids will be awarded on the base bids either by the lowest of all of the trades, or as a lowest combined bid, if that total combined bid is less than the sum of all the lowest combined individual trades.

In accordance with ORC 153.51, the contract may be awarded as a single aggregate contract to the lowest and best bidder. All bidders may bid as follows:

- Any or all trades separately, OR
- Submit a bid for a total **COMBINED BID** for *ALL* trades, **AND** at a minimum, list their bid for the **GENERAL** portion also on the bid form. All bidders bidding a **COMBINED BID** *MUST* list their base **GENERAL** bid on the bid form.

This allows for a combined total bid for one contractor, and if several individuals bid the separate trades, allows for competitive bids between the trades, while still giving a general contractor the low base General bid.

It is further the intent of the Owner to assign the lowest bids for Electrical and Mechanical Plumbing to the lowest bid for the General and Water Treatment. Such assignment will include, the duty to schedule, coordinate, and administer the contracts and all work.

If the successful low bidder for the Electrical and Mechanical/Plumbing bid is not the General Contractor, the successful bidder will be required to provide a performance bond for their contract.

5. BIDDER agrees that the Work will be substantially completed and ready for final payment in accordance with paragraph 14.04 of the General Conditions on or before the dates or within the number of calendar days indicated in the Agreement.

BIDDER accepts the provisions of the Agreement as to liquidated damages in the event of failure to complete the Work within the times specified in the Agreement.
